KNOW ALL MEN BY THESE PRESENTS: THAT SUBJECT TO THE TERMS AND CONDITIONS OF THAT CERTAIN MATER AGREEMENT DATED DECEMBER 23, 1971, 87 AND DETWENT THE LIKE CREEK PRIORYTON COMPANY, SELLER, AND THATE LIKES CORPORATION, BUYER, THATEE LIKES CORPORATION HEREBY INTERVENTED SETS OVER AND ASTIONS TO THE DRIMER OF DRIMERS, THEIR HEIRS, ADMINISTRATORS, EYECUTORS, SUCCESSORS AND ATSIGNS, OF LOTS IN THREE LAKES RAT HO. 14 MANDED, THE RIGHT TO USE ON EACH LOT IN SAID SUBJECTION THE GUARTITY OF WATER REQUIRED TO MEET THE MINIMUM REQUIRE-MENTS OF THE UTAH STATE DEPT.
